## CORPORATE AGREEMENT APPLICATION

This agreement, together with any operating rules, policies, price schedules, or other supplemental documents expressly incorporated herein by reference and published from time to time by Royale Limousine Service (collectively the "Agreement"), constitutes the entire agreement between Royale Limousine Service and you regarding the services of Royale Limousine Service, and supersedes all prior agreements between the parties regarding the subject matter of this Agreement. For purposes of this Agreement, "services" are defined as any and all car and limousine services provided by Royale Limousine Service to you, your agent(s), employee(s) or assign(s) either now or in the future. By using the services of Royale Limousine Service, you confirm your acceptance of, and agree to be bound by this Agreement.

### Charges

a. You agree to pay all charges for your use of the services of Royale Limousine Service at the prices then in effect. Royale Limousine Service reserve the right to change prices or institute new charges for its services. You are responsible for regularly reviewing, obtaining and confirming such pricing information. Continued use of the services of Royale Limousine Service or non-termination of your account after changes are posted constitutes your acceptance of the prices as charged.

b. Prices do not include tolls, parking, extra stops, or waiting time, and all charges will be exclusive of a \$3.00 voucher processing fee and a Chauffeur's gratuity of 20% (twenty percent), which will be automatically added to your bill.

c. You will be invoiced on a bi monthly basis. Payment of your account balance is due upon receipt. You hereby agree to pay all amounts due upon demand. Your account will become past due if such is not paid in full within 30 days of the date of such invoice/bill.

d. Each time you use the services of Royale Limousine Service, or allow or cause the services of Royale Limousine Service to be used, you agree and reaffirm that Royale Limousine Service is authorized to charge your designated credit card.

e. You agree that Royale Limousine Service may (at its option) accumulate charges incurred during your billing cycle and submit them as one or more aggregate charges during or at the end of each cycle, and that Royale Limousine Service may delay obtaining authorization from your card issuer until submission of the accumulated charge(s). This means that accumulated charges may appear on the statement you receive from your card issuer.

### Customer Representations

You represent and warrant that you are at least 18 years of age or, as applicable, the age of majority in the state or province in which you reside, and that you possess the legal right and ability to enter into this Agreement. You agree to be financially responsible for the use of the services of Royale Limousine Service (as well as for use of your account by others, including those persons employed by you and to comply with your responsibilities and obligations as stated in this Agreement.
